IMPORTANT RULE

1. For Normal Member the entry fee is 200/-RS.
2. Member should Give 200Rs per month as Compulsory Deposit
3. CD should be given by member from 10 -15 date of the month at morning.
- 4.100rs is deducted by members account yearly for building fund.
5. Loan form is distributed between 1-5 of every month.
6. For Get loan from society 2 witness is compulsory.
7. Loan distribution per person is 10,000 – 25,000.
8. Interest rate on loan is 1.5% per month .
9. Interest rate on CD is 1% per month.
10. Loan is granted to the member only when the account of member is 1yr old.
11. If Member Doesn't get any witness at the time when they want loan then 75% of there Deposit is scented as loan.
12. Loans distribution processor take place from 19 to 22 every month. (Time: 10:00 am- 7:00pm)
13. At the time of loan Sectioning the witness of family member is not allowed.
- 14.If the member is not Giving CD for 6 month consecutively then Society have right to cancel the membership of that person a nd Society is free to take any kind of action against that member.
15. 2 Female witness is not allowed 1 should be male.
16. After Settlement of Loan from society a person can apply again for the loan after the period of 2 month.
17. If the passbook is lost then 100rs Charge should be paid to society for get the new passbook.
18. Society will Cut all there Charges when the account of a person is Closed.
19. For Female child Marriage member get benefit if there account is 1yr old.
20. Society is independent to take any decision regarding loan or anything.
21. If member get a loan of more than 25,000+ then the member who is getting the loan
Should deposit 10% security money on the Amount of the loan.
22. Giving file charge on loan is Compulsory.
23. If the person who is getting the loan are not giving EMI on time then Society have all power
to increase there interest or take action like Exposing penalty charges on the person.
24. For Optional deposit society give banks saving interest.
